Important Notice 重要通知

1. Prevention of Bribery 防止賄賂

All staff members of GEG have been instructed to strictly adhere to the requirements of the applicable law relating to the prevention of bribery. You are requested to report to the Commission Against Corruption (CCAC) of Macao should any employee of GEG be found having committed any offence of corruption under the said law. Moreover, should any vendor or contractor be found having committed or is believed to have committed any offence of corruption under the said law, GEG shall be entitled to immediately terminate all outstanding contract(s) without entitling the vendor or contractor any compensation or claim for loss. 所有銀娛員工已被指示須嚴守防止賄賂法律的有關規定。若貴公司發現本公司任何員工有違反上述法律,請向澳門廉政公署舉報

2. Declaration of Conflict of Interests 利益申報

To avoid any conflict of interests, vendors are requested to declare any close personal or business relationship with any director, staff and handling agents of GEG. Vendors shall also declare whether he has any interest, shareholdings (legal or beneficial), control, involvement or participation (of whatsoever manner and extent) in any businesses or activities, whether directly or indirectly, in Macau SAR or elsewhere, which are similar or competing with the activities of GEG ("Disclosed Activities") and shall provide all relevant information and material of such Disclosed Activities as per GEG's request from time to time.

The Vendor is required to sign and return, together with this Vendor Registration Form, the **Vendor Master Terms and Conditions** (Appendix A) to signify its acceptance and agreement to the same shall apply to all orders placed to the vendor by GEG from then onward.
